the post 9 11 era has produced structured rehabilitation programmes in a wide range of countries including saudi arabia singapore pakistan malaysia egypt iraq and uzbekistan there are also ad hoc and emerging programmes in nigeria china indonesia bangladesh denmark germany united kingdom and nepal due to the threat from global islamist terrorist groups including al qaeda and the islamic state is the focus has tended to be on islamist groups however sri lanka also has a multifaceted rehabilitation programme that was created after the ethno nationalist liberation tigers of tamil eelam ltte group was defeated in 2009 which can teach us some valuable lessons this book consists of a series of case studies of different terrorist rehabilitation initiatives that have been attempted around the world each initiative is critically analysed to develop a sound understanding of the significance of different approaches and strategies of terrorist rehabilitation in helping potential terrorists integrate back into society sharing and examining case studies by both practitioners and scholars this book provides vital tools to address the challenges faced by practitioners of terrorist rehabilitation programmes

without money terrorists cannot function as organizations and cannot conduct attacks yet the questions remain how vulnerable are terrorists to financial disruptions can governments put pressure on their finances in meaningful ways or are they too resilient and adaptive to be affected by state actions these and other questions about terrorism financing are vigorously debated by scholars and policymakers particularly since the attacks of september 11th 2001 while there is a growing literature on policy issues strategies and countermeasures states must first understand their enemies before developing strategies to defeat them so instead of focusing on the state response this book asks a more foundational question how do different terrorist groups actually raise money what are their budgets what do their portfolios look like how have they changed over time what are the advantages and disadvantages of different sources of financing the book includes case studies of 11 different terrorist groups or sets of groups within a country it is clear that each group has a different portfolio tailored to their needs and their environment and this makes countering terrorist financing more challenging for the state this topical book will be required reading for all students and scholars interested in terrorism financing as well as those working in government agencies tasked with combating terrorist groups and their financial resources

concern journalists academics and policy analysts have considered the subject and in most cases found much to alarm them most significantly it has captured the attention of policy makers at all levels of government in the united states unfortunately bioterrorism remains a poorly understood subject many policymakers and policy analysts present apocalyptic visions of the threat contending that it is only a matter of time before some terrorist uses biological agents to cause mass casualties in contrast other analysts argue that the empirical record provides no basis for concern and thus largely dismiss the potential threat neither approach is helpful imagining catastrophic threats inevitably leads to a requirement for impossibly large response capabilities in contrast denying the potential danger altogether leads to the kind of tunnel vision that led u s intelligence officials to totally ignore the emergence of aum shinrikyo in japan despite its overtly hostile attitude towards the united states this study takes an intermediate course it provides empirical evidence to support the views of those who argue that biological agents are difficult to use it also provides abundant evidence that some people have desired to inflict mass casualties on innocent populations through employment of biological agents fortunately these accounts also suggest that such people lacked the capability to follow through with their plans the research also casts considerable doubt on our ability to predict which biological agents a perpetrator might employ while some analysts assume that terrorists will use those agents that proved of most interest to state weapons programs bioterrorists and biocriminals have acquired and used agents of little or no value as weapons of war

the author identifies 68 indicators of terrorist activity and analyses each with a step by step explanation he also outlines safeguards against 38 of the 42 common warning pitfalls by following khalsa s methodology analysts can recognize and assess terrorist activity and thus provide warnings that will help prevent attacks
